**Constitution of India** **No. GK/23/2023/SUP/102015/74/D:-** In exercise of the powers conferred by the proviso to Article 309 read with article 234 of the Constitution of India and as per the Order dated 19.05.2023 of Hon'ble Supreme Court of India in the Writ Petition(Civil) No-643/2015, the Governor of Gujarat hereby makes the following rules further, to amend the Gujarat Subordinate Judicial Service (Revision of Pay) Rules, 2022.

1. Short Title and Commencement:

(1) These rules may be called the Gujarat Subordinate Judicial Services (Revision of Pay) (2<sup>nd</sup> Amendment) Rules, 2023.

(2) They shall be deemed to have come into force with effect from 01.01.2016.

2. In the Gujarat Subordinate Judicial Services (Revision of Pay) Rules, 2022 herein after referred as said rules, in Rule-2 after the words "Subordinate Courts" the words "including the Industrial Tribunal and Labour Courts" shall be inserted.

3. In the said rules for rule-8 the following rule shall be substituted, namely:

**"8. Dearness Allowance**

The sanction of Dearness Allowance (DA) to the Judicial Officers of the Subordinate Judiciary shall be at the rates prescribed by the Central Government from time to time. The benefit of revised DA in conformity with the orders issued by the Central Government from time to time shall be paid to the Judicial Officers with immediate effect and in any case, not later than 3 months from the date of issuance of the order by the Central Government. The benefit of revised rates of DA shall accrue from the effective date as specified in the Order issued by the Central Government in this behalf."
