No. GK/02/2023/SUPC/102015/74/D(Part-I):- In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Gujarat Subordinate Judicial Services (Revision of Pay) Rules, 2022. namely: -

1. (1) These rules may be called The Gujarat Subordinate Judicial Services (Revision of Pay) (Amendment) Rules, 2023.

(2) They shall be deemed to have come into force on the 1st January, 2016.

2. The Gujarat Subordinate Judicial Services (Revision of Pay) Rules, 2022. (hereinafter referred to as the said rules), in Rule 14, for the words and figures "the Gujarat Civil Services (Pay) Rules, 2009 (as amended from time to time)" wherever they occur, the words and figures "the Gujarat Civil Services (Pay) Rules, 2002 (as amended from time to time)" shall be substituted.

3. After rule 8 of the said rules, the following rule shall be inserted, namely: -

"8A leave encashment:

(1) Leave encashment as admissible to the State Government employee shall be admissible from time to time to the Judicial Officers as per the Gujarat Civil Services (Leave) Rules, 2002 as per the pay revised by the Gujarat Subordinate Judicial Services (Revision of Pay) Rules, 2022.

(2) A Judicial Officer shall also entitled to get Encashment of Leave and Leave Salary in accordance with the Legal Department Resolution NO. PAY/102003/1233/D dated the 16th March, 2007 as per the pay revised by The Gujarat Subordinate Judicial Services (Revision of Pay) Rules, 2022.

4. After rule 11 of the said rules, the following rule shall be inserted, namely:-

11A Promotion: Judicial Officer shall be entitled to get increment in accordance with the provisions of **rule 11(I) of the Gujarat Civil Services (Pay) Rules, 2002** at the time of promotion, Assured Career Progression, Selection Grade and Super time Pay Scale.
